Non-profits may sell goods to raise money for their organizations.

In order for the application to be approved, you must also sign the following Release of Responsibility: In consideration of your accepting my application and my participation in the events of the 2024 Oakland in October Festival, I do hereby release forever and hold harmless any and all rights and claims for damages I may accrue against any and all persons, businesses, agencies and other participants, including, but not limited to: Oakland Regional Chamber, its officers and Board of Directors, the organizers, sponsors, workers, officials, volunteer helpers, the Fayette County Schools, Fayette County, Tennessee, Oakland, Tennessee and representatives, and assigns.

The event will be held rain or shine. Participants are responsible for providing their own tents, tables, chairs, & display items.
